b. Fire Chief - Stacey

- They had their first meeting at the new fire station
- Issues with 83 and 82 but will be addressing issues
- Quarterly pay for volunteers there was one question, but then all firemen agreed
- Randy from Bowman showed up at North Station to address the heating problem he installed mixer value and also placed elbow on drain to prevent sewer gases. The heating system may either be extremely hot or cold. Selectmen informed Stacey to stay on top of Bowman to get the problem corrected.
- Number was run for Embden fire calls and there was 44 for 2024, 3 questionable (location could not be determined) and the storms were included in this number. Total calls 194 or 195 for all fire fighters including full time (full time for two was 66)
